Position Purpose

Performs a variety of working-class level and technical duties to repair, maintain, and deliver waste containers for all divisions of NCSWA.

Essential Duties and Responsibilities

Performs repairs to include welding and fabrication, and part replacement, maintenance including painting, grease and lube of parts, cleaning, and site pick-up and delivery of waste containers to customer site and return for NCSWA.

Obtains quotes for best price for necessary tools and supplies needed to carry out the functions of the positions, may prepare requisitions to obtain purchase orders.

Operates hand and power tools, as well as welder as needed in the scope of duties.

Utilizes a scissor lift for repair, lifting and moving of bins. Operates a truck with or without a trailer to deliver and return bins to customer sites.

Performs other duties as assigned.

Minimum Mandatory Qualifications

Education: High School Diploma or equivalent.

Experience: 1 year of experience in a related field.

Knowledge, Skills, Abilities, Equivalent combination of relevant education and experience may be substituted as appropriate.

- Ability to operate a scissor lift, truck with or without trailer, welder and various power and hand held tools.

- Working knowledge of the area serviced by NCSWA, customer sites, bin types, and welding.
- Must possess and maintain a valid, unrestricted class D drivers' license or able to obtain license within six months of hire.

Two (2) years of general labor experience with power and hand tools

Work Environment

Work environment: The work is performed inside and outside in all weather conditions with potential hazards including exposure to sun, wind, rain, snow, dust and traffic. Possibility of physical risk. Possible exposure to harmful fumes, and toxic or caustic chemicals.
